Dear Ms. Quinn:

We have reviewed the amended Multiyear Implementation Plan from Gulf County originally submitted on July 18, 2023, and deemed complete on August 8, 2023. We find that the Gulf County Multiyear Plan Amendment #3 is complete and appears to conform to the RESTORE Act and regulations. As of the date of this letter, Treasury accepts Gulf County's Multiyear Plan Amendment #3 that proposes an additional contribution of \$5,069,983.03 from the \$5,083,011.00 Direct Component funds available in Gulf County's allocation in the Gulf Coast Restoration Trust Fund (Trust Fund). The County can begin to prepare and submit applications through the RESTORE Grant Management System for activities included in the accepted amended Multiyear Plan.

We will post all accepted Multiyear Plans on Treasury's RESTORE Act website. In addition, please post Multiyear Plan Amendment #3 on your County's website and provide us with the web address so we can include the link on the Treasury RESTORE Act website.

Treasury's acceptance of Multiyear Plan Amendment #3 is not a final determination of the eligibility of activities, projects, and programs for Direct Component funding and does not bind Treasury to obligate funds from the Trust Fund. The County must submit an application for Direct Component funding separately through the RESTORE Grant Management System. Treasury will review the application to determine if the requested funding complies with the RESTORE Act and regulations, and Federal law and policies on grants. Applicants may submit applications only to seek funds already available for distribution from the Trust Fund, in accordance with allocations established under the statute. In the future, whenever there is a material change in the Multiyear Plan, Gulf County must follow the requirements for an initial Multiyear Plan, including those for public review and comment. On behalf of the Gulf County Board of County Commissioners (BOCC),

The Gulf County Board of County Commissioners (BOCC) reviewed and approved the proposed project list for the MYIP Amendment-03 at the June 28, 2022 meeting and revised the list at the January 24, 2023 meeting. The proposed projects were developed based on public and stakeholder input in the initial MYIP process as well as matching projects proposed for the Restore Act and current needs for our area.

The Gulf County MYIP Amendment-03 was made available for public review and comment from April 20, 2023 until June 4, 2023. No public comments were received during this period.

NARRATIVE DESCRIPTION:

1. A description of each activity, including the need, purpose, objective(s), milestones and location. Include map showing the location of each activity.

It is the intention of the Board of County Commissioners and Staff of Gulf County, Florida to implement the (2) proposed projects in this MYP Amendment-03. The projects are expected to be performed during a 4-year period and may be completed in phases as funding becomes available.

Water System Improvements

Description: The Gulf County Water System provides water to more than 2,000 customers located in the southernmost areas of Gulf County (Cape San Blas, Indian Pass, Simmons Bayou, and Jones Homestead). Prior to Hurricane Michael, customers of this system were serviced by two production wells, both of which are located within a few hundred feet of the coastline. The storm surge from Hurricane Michael destroyed one well, causing the system to operate with only one production well from October 2018 to April 2021 causing issues with meeting demand, low pressures, etc. The County has re-constructed one well and repaired and improved the system, but continues to experience volume and pressure issues in addition to the risk of storm surge and future damage. The County has received grants to construct the inland water plant and booster station and portions of the transmission main. This project is seeking additional funding necessary to complete the transmission main connecting the booster station to the distribution system.

Need: The Gulf County Water System needs to be moved further away from the coastline in order to ensure that it is protected from natural disasters, like tropical storms and hurricanes. Customers were serviced by only one production well for roughly 30 months because of a hurricane putting one of the production wells out-of-service. Both wells are now operational, but the County continues to address issues regarding volume (quantity) and pressure needed to meet customer demands. Demand for more volume and better pressure continues to grow as the area rebuilds post Hurricane Michael.

Purpose: To construct water transmission lines connecting the proposed inland water system to existing costal service area. This will move the water source away from the coast to mitigate the risks associated with storm surge and saltwater intrusion.

Objective: The objective of this project is to construct water transmission lines that will connect the existing costal customers and move away from the coast and the threats of storm damage and flooding. This project will ultimately increase system capacity, resiliency, efficiency, enhance water quality, decrease flood hazards, and mitigate damage to sensitive habitats.

Milestones: 1) prepare bid package meeting U.S. Treasury specifications and solicit bids for construction; 2) select contractor and award contract agreement; 3) complete construction.

Airport Pre-Construction

Description: Gulf County currently has no means of airport transportation. However, the County experiences a high influx of tourists from March to September that increases the demand on our transportation systems and economy. A 2019 Pre-Feasibility Study indicated that airport development in Gulf County is feasible.

Need: The development of air transportation will kickstart the economic revitalization desperately needed for the County and region. The development of an airport in Gulf County compliments the roads and rail infrastructure that services the area. Additionally, the area being prone to hurricanes and other natural disasters increases the need for a centralized location to stage post-disaster recovery operations, supply needs, as well as having another avenue to evacuate residents and tourists.

Purpose: To design, permit and plan construction of an airport that would benefit the economy in Gulf County.

This project will cover the planning, design, permitting and other pre-construction needs for the future airport.

Milestones: 1) prepare bid package meeting U.S. Treasury specifications and solicit bids for design and permitting; 2) select contractor and award contract agreement for design and permitting; 3) conduct design and permitting.

Airport Construction

Description: Gulf County currently has no means of airport transportation. However, the County experiences a high influx of tourists from March to September that increases the demand on our transportation systems and economy. A 2019 Pre-Feasibility Study indicated that airport development in Gulf County is feasible.

Milestones: 1) prepare bid package meeting U.S. Treasury specifications and solicit bids for construction; 2) select contractor and award contract agreement; 3) complete construction.

The Gulf County Board of County Commissioners reviewed and approved the proposed project list for the MYIP amendment at their regularly scheduled meeting on June 28, 2022 and revised the listed at their regularly scheduled meeting on January 24, 2023.

Public Comments were allowed as is per common practice at all County Commission Meetings. The proposed projects were developed based on public and stakeholder input in the initial MYIP process as well as matching projects proposed for the Restore Act and current needs for our area.

The document was made available to the public for review and comment from April 20, 2023 until June 4, 2023 (a 46-day period).

The Gulf County Board of County Commissioners published NOTICE that the Draft MYIP was available for the Public's review and comment during the 45-day period at the following locations:

The Gulf County Board of County Commissioners accepted the MYIP Amendment-03, including each activity in the plan, and voted to approve it after consideration of public comments after the 46-day public comment period. The Gulf County Board of County Commissioners voted to approve the MYIP Amendment-03 on June 26, 2023. There were no public comments received during the 46-day public comment period.

3. Water System Improvements

Primary Eligible Activity: Infrastructure projects benefitting the economy or ecological resources. Constructing a new water plant in a location that will mitigate issues such as flooding, saltwater intrusion, storm surge, etc., will provide the County with a water plant that is resilient, efficient, and enhance water quality.

Geographic Requirement: The new water plant would be located in Gulf County. Please see attached map.

Airport Pre-Construction

Primary Eligible Activity: Planning project that will lead to an infrastructure project that will benefit the economy of Gulf County.

Geographic Requirement: The new airport would be located in Gulf County. Please see attached map.

Airport Construction

Primary Eligible Activity: Infrastructure project benefitting the economy or ecological resources. Constructing a new airport will boost Gulf County's economy.

Geographic Requirement: The new airport would be located in Gulf County. Please see attached map.

5. How the activities included in the multiyear plan narrative were prioritized and list the criteria used to establish the priorities.

The Gulf County Board of County Commissioners, with staff, and the County's RESTORE Act Committee and outside consultants, developed the initial MYIP for Gulf County. From the original list of proposed projects, (1) project was accepted in the initial MYIP submitted in 2017. The proposed projects in this MYIP Amendment include some of the projects proposed in the initial process, and further refined by the Board of County Commissioners and staff. As the Board of County Commissioners has moved through this process, project priorities have changed due to local factors and developed priorities. These priorities include new water infrastructure and airport access. While the BOCC remains committed to all projects originally outlined in the MYIP, need and necessity has required the Board to reevaluate timing and priorities. The projects in this MYIP- Amendment #03 were prioritized and ratified by the Board of County Commissioners at the June 28, 2022, meeting and January 24, 2023.

6. If applicable, describe the amount and current status of funding from other sources (e.g., other RESTORE Act contribution, other third party contribution) and provide a description of the specific portion of the project to be funded by the RESTORE Act Direct Component.

Water System Improvements

The Direct Component funds will be used to cover construction activities as funds permit. The additional construction costs will be funded separately by Community Development Block Grant Disaster Recovery (CDBG-DR) and Department of Environmental Protection Resilient Florida Grant. Gulf County did not receive funding from FEMA after Hurricane Michael hit in 2018 due to the County not owning the property at that time. Gulf County took ownership of the water system in November 2020. However, Gulf County has submitted three alternate projects to FEMA for enhancements to the water system that are separate from this project.

Airport Pre-Construction

The Direct Component funds will be used to cover the planning, design and permitting costs as funds permit. Other third-party funding is provided from Florida Appropriations 2022-2023 through the State of Florida Department of Transportation; grant agreement has been executed, and money has been bookmarked for this project.

Airport Construction

The Direct Component funds will be used to cover the construction activities as funds permit. Additional funding will continue to be sought from other third-party sources; Gulf County continuously searches for other funding sources. Gulf County is aware that this funding is not sufficient to complete the project and will not submit an application for funding until other funding has been secured to cover the rest of the project's budget.
